GMR subsidiary signs MoU with Oman Airport Management Company to Provide Training & Consultancy Services

- ***GMR to provide consultancy services and support Oman Airport Management for smooth take-over of the New Terminal at Salalah Airport***
- ***Aviation Consultancy is becoming a steady revenue stream for GMR, with the completion of four international projects and more in the pipeline***
- ***GMR in dialogue with other airports for similar projects in Middle East and South East Asia.***

NEW DELHI, JUNE 17, 2015: GMR Airport Developers Limited (GADL), a subsidiary of GMR Infrastructure Limited, has signed a Memorandum of Understanding (MoU) with Oman Airport Management Company (OAMC) for providing training and consultancy services. As per the MoU, the GMR subsidiary will provide services ranging from program management, testing and commissioning of airport systems to development of aeronautical and non-aeronautical revenue streams.

Speaking on this occasion Mr. Srinivas Bommidala, Business Chairman Airports, GMR Group said, "GMR Group is the world's 4th largest private airport developer and possesses end to end capabilities in the airport space. In line with our stated *Asset light Asset right strategy*, GMR has been engaging with and offering consultancy services to airport companies in the Middle East and South East Asia. We are honoured that Oman Airport Management Company has signed a comprehensive MoU with GADL, aimed at knowledge sharing and skills development for the OAMC staff."

In line with the MoU, GMR subsidiary will provide on-site support for six months at Salalah Airport, which will help OAMC team to learn and adapt some of the best practices of Delhi and Hyderabad airports. OAMC team may also undergo trainings at GMR Aviation Academy – one of the few academies in the world to have received the coveted RTCE certification.

GMR Group constructed Delhi Airport in World Record time of 37 months and made it World's No.1 airport - from 101 ranks in 2006 - in its category. The company's Hyderabad airport has consistently ranked among World's top three airports in its category over the last 7 years.

About GMR Infrastructure Limited:

GMR Infrastructure Ltd. is a Bangalore headquartered Infrastructure group with interests in Airports, Energy, Highways and Transportation & Urban Infrastructure sectors. It has successfully employed the public-private partnership model to build a portfolio of high quality assets.
